Explanatory Notes for the material variances:

1. The total difference of \$5,100,000 from investments in subsidiaries is mainly due to the impairment in respect of the investment in a wholly-owned subsidiary, KOP Properties Pte. Ltd. ("**KOPP**").

Management has carried out a review of the recoverable amount of the investments in subsidiaries, having regard to the existing performance of these entities and the carrying value of the net assets in these entities.

Based on the valuation reports dated 3 July 2017 issued by the independent valuer, the Company is of the initial view that there is no indication of impairment in relation to the carrying values of the net assets. However, after taking into consideration external auditors' opinion, the Company assessed that there is an additional impairment loss amounting to \$\\$5.1 million.
